# **VOLUNTEER VOICES**Hannah Reception and Grocery Volunteer



**Q:** How long have you been volunteering for the Society?

A: For about 4 months; I started in October of 2019.

**Q:** What kind of things do you do as a volunteer?

**A:** On Fridays I volunteer one day a week as a receptionist, answering phones, taking messages, and stamping the occasional large stack of envelopes. Every other Wednesday I do grocery order, which entails calling a few friendly seniors and ordering their groceries online to be delivered to their homes.

**Q:** Why did you decide to volunteer for the Seniors Services Society of BC?

**A:** Besides having the extra time as a new resident of Canada, I have always felt that it is important to help those who cannot help themselves; to make time for altruism. In the past, my volunteer work has been with children or individuals with special needs and I thought this might be a nice change of pace.

**Q:** What is your favourite part of volunteering for the Society?

**A:** I truly enjoy chatting with my new friends on the phone during grocery order and getting to know them, bits and pieces of their stories, and hearing about their cats.

### THE HIDDEN FACE OF HOMELESSNESS

·A portion of the clients that approach the Seniors Services Society of BC for help come from difficult and traumatic situations. Recently Alissa, one of our Seniors Housing Outreach Workers, came to the assistance of "Mary", a woman fleeing a 25-year long abusive relationship. Leaving all her worldly possessions behind except the clothes she was wearing, she found refuge on a friend's couch in a single occupancy apartment. Unfortunately the tight living arrangement took its toll on both of their physical and mental health, and created a risk of the friend being evicted.

With Alissa's help, Mary learned to create a monthly budget, something she never had the opportunity to do before, as her ex-spouse had controlled the household income and expenses. With a budget in place and a newly acquired rent supplement, Mary was able to move into a new apartment, a space where she finally feels safe and secure. Her journey has been difficult, to say the least. However with Alissa's help, she now looks forward to integrating into a new community.

Another client, "Joan", had previously lived with her son until his death. Joan spent a few years after bouncing among her family members' homes, without ever having a place she could call her own. This situation came to a head when her sister moved out of the country, and she found herself sleeping on her nephew's couch. With the house being very busy with children and pets, there was little in the privacy for Joan, or her nephew and his family. She however was on disability, and was not bringing in enough money to afford a place of her own.

Alissa was able to secure a housing subsidy for Joan, and provide her with outreach services, including finding her a new home. Now Joan lives in a basement suite a mere three blocks from her nephew- the only support she has left in Canada.

For many seniors, stories like Mary's and Joan's are all too familiar. Fortunately, Alissa and the Seniors Services Society of BC are here to help.
