THE IMPACT OF CORONAVIRUS AND COVID-19

The weekend of March 14th/15th, 2020 would prove to be one that would shake up not just the Seniors Services Society of BC's operations, but all of North America, as the novel coronavirus and the condition it caused, COVID-19, prompted a lockdown of the province of British Columbia and Canada at-large.

Even as businesses and other organizations shut down, the Seniors Services Society continued on. Recognising the increased need for seniors' supports caused by the pandemic, provincial and municipal governments reached out to the Society for assistance. The Seniors Services Society of BC became one of twenty-four response hubs across the province, under the direction of the United Way of the Lower Mainland.

The Society expanded services for grocery shopping, check-in calls, meal delivery, and prescription pick-up. This increase in services ensured isolated seniors had access to the support they needed, including those who had formerly been fully independent, but were heavily impacted by the pandemic. These increased services would not have been possible without community partners from both the charitable and the corporate sector.

And of course, there are our volunteers. The people of New Westminster, who in the face of the coronavirus, donned masks and hand sanitizer and went out to the supermarkets and the pharmacies to purchase groceries and prescriptions for seniors trapped at home. Their commitment to our seniors-in-need has been unwavering and compassionate.

A NEW CHAPTER

The Seniors Services Society of BC has established a Community Response Network (CRN) for New Westminster to address the issue of adult abuse, neglect, and self-neglect. The New Westminster CRN is part of the BC Association of Community Response Networks, whose mandate is to gather a diverse group of concerned community and health service organizations, government agencies, community-minded individuals, local businesses, and seniors to develop a coordinated response to cases of adult abuse, neglect and self-neglect.

Elder abuse often goes unreported. The Ministry of Health reports as many as 10% of BC seniors will experience some form of abuse in their later years. One-in-twelve seniors will experience financial abuse caused by close family members or trusted friends. It has been reported that those statistics have risen since the advent of the COVID-19 pandemic, with reports of online and telephone scams aimed at seniors.

The mandate of the New Westminster CRN is to provide a foundation for the whole community to work together as a team in creating the safe, supportive community that everyone wants to live and grow old in. This can be achieved by building awareness and educating workers, friends, family members, caregivers, and neighbours in contact with vulnerable adults on how to recognize the signs of abuse and neglect and where to go for support.

The Seniors Services Society of BC is the host organization for the New Westminster CRN, and is looking forward to holding the first meeting of the New Westminster CRN Advisory Committee later this summer.

THE HIDDEN FACE OF HOMELESSNESS

A portion of the clients that approach the Seniors Services Society of BC for help come from difficult and traumatic situations. Alissa, one of our Seniors Housing Outreach Workers, came to the assistance of "Mary", a woman fleeing a 25-year long abusive relationship. Leaving all her worldly possessions behind except the clothes she was wearing, she found refuge on a friend's couch in a single occupancy apartment. Unfortunately the tight living arrangement took its toll on both of their physical and mental health, and created a risk of the friend being evicted.

With Alissa's help, Mary learned to create a monthly budget, something she never had the opportunity to do before, as her ex-spouse had controlled the household income and expenses. With a budget in place and a newly acquired rent supplement, Mary was able to move into a new apartment, a space where she finally feels safe and secure. Her journey has been difficult, to say the least. However with Alissa's help, she now looks forward to integrating into a new community.

Another client, "Joan", had previously lived with her son until his death. Joan spent a few years after bouncing among her family members' homes, without ever having a place she could call her own. This situation came to a head when her sister moved out of the country, and she found herself sleeping on her nephew's couch. With the house being very busy with children and pets, there was little in the privacy for Joan, or her nephew and his family. She however was on disability, and was not bringing in enough money to afford a place of her own.

Alissa was able to secure a housing subsidy for Joan, and provide her with outreach services, including finding her a new home. Now Joan lives in a basement suite a mere three blocks from her nephew- the only support she has left in Canada.

For many seniors, stories like Mary's and Joan's are all too familiar. Fortunately, Alissa and the Seniors Services Society of BC are here to help.

A: I volunteered at Century House in 2007, where I chaired the City's Seniors' Planning and Action Network (SPAN). With my contributions to seniors in the community, Seniors Services Society (SSS) asked me to join their board.

A: From past volunteering, I embraced providing housing for those in need. This passion and my commitment to helping seniors made the Society an obvious fit. I was happy to join an organization that was positively impacting seniors through housing, Meals on Wheels, and other programs.

Q: Your final term is coming to a close after eight years on the board. When you look back, what do you think was your greatest contribution?

A: I encouraged team building among the board, increased communications between board and staff, encouraged diversity of board members, and saw board and staff move forward with an aligned vision to expand fundraising, and community awareness.

Q: Do you have any advice for future board members to help them be successful in the role?

A: Board members must ensure the needs of vulnerable seniors are kept front and center. Housing is the precursor to the many other valuable services, and to the ability of seniors to live independently, with dignity and respect.
